### Re-inspection Fee: (Second and subsequent visits)

- **Pinellas Park (Current)** – None
- *Pinellas Park (Proposed)* – *Initial inspection fee charged for any visit finding violations. No charge for any trip finding violations corrected*
- **St Pete** – Second visit free, third trip is twice the initial fee, and subsequent trips are actual cost plus 25%
- *St Pete (Proposed)* *Twice the initial inspection fee.*
- **Largo** – second visit is 1.5 times initial fee, third and subsequent is twice. No fee for trip finding violations corrected.
- **Clearwater (Current)**– None
- *Clearwater (Proposed)* - *first re-inspection is free, second re-inspection is twice the initial fee.*
- **Pinellas County** – County is proposing to allow fire districts charge same as City fees.
