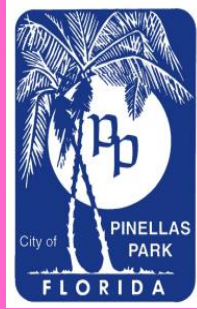


# City of Pinellas Park Reclaimed Watering Schedule



## Three Days a Week

**Please follow the watering schedule below based on your address.**

| <b>Addresses ending in:</b>  | <b>Authorized Watering Days:</b>   |
|--|------------------------------------|
| <b>EVEN</b> numbers: <b>0,2,4,6,8</b>  | Tuesday, Thursday, and/or Saturday |
| <b>ODD</b> numbers: <b>1,3,5,7,9</b>   | Wednesday, Friday, and/or Sunday   |
| <b>Locations with no or mixed addresses</b><br>(Common areas, entry areas / office complexes, shopping centers.) | Wednesday, Friday, and/or Sunday   |

**Rules include:** New lawn or plant materials only may be watered on all available days during authorized hours for the first 30 days after installation and three assigned days for the next 30 days thereafter.

## City Water, Well, Lake and Pond Watering Restrictions

Watering is prohibited between the hours of 10:00 a.m. and 4:00 p.m.

### CURRENT WATERING RESTRICTIONS

| If your house number ends in   | Then you are allowed to water on |

| EVEN numbers 0,2,4,6,8   | Thursday and/or Sunday           |
| ODD numbers 1,3,5,7,9  | Wednesday and/or Saturday        |
| Mixed or No Address  | Tuesday and/or Friday            |
| <b>Properties (2) two acres or greater</b> in size may water ½ on Thursday and/or Sunday and may water the remained ½ on Wednesday and/or Saturday.  |                                  |
| <b>Hand Watering and micro-irrigation of plants</b> (other than lawns) can be done on any day.   |                                  |
| <b>Watering is prohibited between the hours of 10:00 a.m. and 4:00 p.m.</b>  |                                  |
| <b><u>New Lawn and Plants</u></b>  |                                  |
| <p>On the day of installation, watering is allowed on any day at any time.<br/>           During days 1-30, watering is allowed on any day during the allowable hours.<br/>           During days 31-60, water is allowed three days per week.</p> <p><b>Even</b> numbered addresses – add Tuesday<br/> <b>Odd</b> numbered addresses – add Monday<br/> <b>Mixed or No</b> addresses – add Sunday</p>  |                                  |
